Ki Mobility Growable

When ordering a Tsunami Little Wave XP it is always appropriate to ask the question as to whether or not you feel that depth adjustment is going to be needed. Without charge, you can always request that three inches be left on the back of the frame and even have the upholstery be the extra three inches as well. That way if you need to grow the unit lengthwise there is simply an in house adjustment moving the backrest back and resetting the center of gravity.

At this stage it is cost prohibitive to put an insert in the back of the seat rail to extend the seat length.


Performance/Classic



On the Ki Mobility Tsunami, Tsunami Little Wave, and Rogue units the Performance Position (0") is selected, the sling is at the front of frame to

keep the chair shorter and be more manoeuvrable.

The sling can be set back 1" or 2" (classic position) leaving more frame in front of the sling to



improve overall stability (lengthen the wheelbase which is from the back axle to the middle of the caster pot or in line with the stem bolt), aid in transfers, or assist with leg positioning.

MDEL Audit

We had the pleasure of hosting the Medical Device Establishment Licensing folks this month. You may recall my rants on the **250% fee increase** a couple years ago and the statement that the increases would continue at a rate of 2% annually. This year it is \$7,641.00 or 1% of your gross revenue, whichever is less (that last part makes me

feel so much better because when I add up the %'s that we have to give people and organizations in the chain it ends up being more than 100% which makes life tough in business).

The comparable fees in the USA, Australia, and European countries for the privilege of doing business in those jurisdictions is considerably less. Canada has this 100% cost recovery concept that must be based on a large number of employees with significant expense accounts. But, I guess we should not complain because the cost recovery process has only just begun; we will likely start to experience costs associated with inspections and the number of inspections, which apparently are once every four years, will likely change to annual or even more often when the government of the day charges for same.

I recall a TV series where Tony Soprano was knocking on some business persons door every week to pick up a wad of cash; the fees associated with MDEL's does not seem a whole lot different than that except that the business man is beat up in a different way!

In the instances where we have been audited and found compliant, the individuals were exceptional to deal with; they came from Carmelo's side of the Soprano marriage and stressed the importance of their work in the other classes of devices brought into the country. Class 1 devices, like wheelchairs, have the least amount of general public risk associated with them and it would seem to me to make sense that those establishments importing, distributing, or manufacturing those products should be charged a lesser fee than the higher risk Class 2, 3, and 4 products.
